STAFF

The parish clerk is the sole employee. He works 10 hours per week at £11.50 per hour. This is £11 per hour for parish council work and a £520pa payment for village hall accountancy and clerical duties. I propose a 3% increase (CPI is 2.7%).

Note: The council will agree remuneration with the new clerk, but national bands are higher for this category of clerk so the budget may be exceeded. I have also included an extra 'double' month to allow for a handover.

Pension: The council is enrolled for workplace pensions for the clerk, but as my salary is less than the $\pm 10,000$ pa threshold I am not obliged to request a pension and I have again declined to request one.

OFFICIALS

The chairman of the parish council has indicated he will again forego the annual allowance of $\pounds 500$ but it will remain within the budget, particularly as he has indicated this will be his last year in office.

CONTRACTORS

All other 'staff' signed self-employment disclaimers. An increase of approximately 3% is recommended from April 2019.

BUDGET

LOAN

The Public Works Loan balance currently stands at £111,241.76. The loan is due to be paid by 3/12/2032.

PRECEPT

I propose that the precept is increased to £41,880 for the coming year, which means the Council Tax for a Band D property would be the same as last year at £111.65 or £2.15 per week (based on recent data received from MSDC indicating that the Laxfield tax base will be 375.1 (was 371.7), an increase of 0.9%.

LAXFIELD CEMETERY FEES

Having increased some fees last year, I propose no changes:

- a. Do not include costs of digging or filling a grave.
- b. Apply only where the interment is made between 10am and 4pm on a weekday or on the certificate of a coroner or registered medical practitioner that immediate interment is necessary. In any other case an additional £20 is payable.
- c. Apply provided the interment is made within 30 minutes of the time arranged with the Clerk to the Parish Council. If not so, an additional £20 is payable.

NOTE: For any person who at the date of death was not resident within the parish boundary, fees are doubled, with a minimum charge of £150.00.
